P. 147 **2016-04-013 Home Visitation Proposal:** Commission to review, discuss and consider approving the use of Innovation Funds to allow Commission staff to pursue a voluntary home visitation program.

Program Officer Waite provided feedback and status of home visitation proposal. He gave a brief outlining of why a home visitation program would benefit Kings County including percentage of Kings County children living in poverty and the benefit of early intervention. Program Officer Waite added that the home visitation program would operate out of the First 5 Kings County Family Resource Centers. Executive Director Grice added that the home visitation

program would have a focus on children living in Avenal and Corcoran due to those towns living at the highest poverty rate. Commissioner Mary Anne Ford-Sherman asked if all funding was billable. Program Officer Waite described the health portion of the project will be billable however First 5 Kings County would have to look for additional revenue sources regarding the early childhood education and parenting portion. Commissioner Dr. Mac Lean asked why not simply expand the current services at the Family Resource Centers. Executive Director Grice replied not all services are the same between sites and there are logistical limitations regarding size of FRC. Commissioner Bugay commented services would be beneficial. Commissioner Dr. Mac Lean added his only concern would be designing a program that would duplicate services that are already available.
