Dr. Michael Mac Lean commented that the previous minutes do not reflect the comments he made regarding the proposed Home Visitation program. He noted he was concerned regarding going forward with the home visitation program due to it being an expensive program that is not population based. He believes it will only reach a small number of children and not population based. He would like for all children in the county to be taking advantage of First 5 Kings County funding. Additionally he stated that if the Health Department feels that this a valuable service why are they not investing realignment dollars?

## **Informational Agenda Items**

**3<sup>rd</sup> Quarter Grantee Achievement Report:** Commission to review and discuss the progress of funded projects through the first three quarters of FY 15/16.

Program Officer Waite commented on Linkages to Learning program expenditure, that teachers are paid once a year. He also added that backpacks have yet to be ordered which also affects current program expenditure.

**Spotlight on Service:** Staff from West Hills Community College District will present an overview of the funded project Avenal Family Connection.

Patty Gonzales, Coordinator at Avenal Family Connection and Dulce Ochoa, Family Advocate at Avenal Family Connection informed First 5 Kings county commission of the services provided. Commissioner Ford Sherman commented she would like to make sure Avenal Family Connection has access to Kings County Mental Health referrals. Dr. Michael Mac Lean asked why physical fitness goal was low for the Avenal Family

Connection. Program Officer Waite replied because it is a more expensive service to provide. Dr. Michael Mac Lean also recommended Patty Gonzales and Dulce Ochoa to have nutritional posters available to give parents ideas of how much sugar are in sodas or snacks. Dulce Ochoa commented Cal Fresh does an amazing job teaching parents about food portion sizes.

**Staff Report:** April 2016

Program Officer Waite commented staff reports are as written. Waite added tobacco purchase age will be changed from 18 to 21. Commissioner Ford-Sherman added Linkages to Learning has a large participation rate. Program Officer Waite added Lemoore area schools will all be joining the Linkages to Learning program next school year.
